This instrument memorializes and constitutes an ASSIGNMENT made in August 1999 by and between Technology Innovations, Inc., a corporation organized under the laws of, and having its principal place of business in, the State of New York, and Technology Innovations, LLC, a corporation also organized under the laws of, and having its principal place of business in, the State of New York.

On June 30, 1994, the U.S. Patent and Trademark Office recorded at Reel 7069 Frame 268 an assignment pertaining to an invention described in U.S. Patent Application Serial No. 08/269,920 entitled DEVICE FOR INCLUDING ENHANCING INFORMATION WITH PRINTED INFORMATION AND METHOD FOR ELECTRONIC SEARCHING THEREOF (the "1994 Assignment").

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, TECHNOLOGY INNOVATIONS, INC., a corporation organized under the laws of, and having its principal place of business in, the State of New York, DOES HEREBY ASSIGN all of its right, title and interest worldwide in and to the invention described in the U.S. patent application entitled DEVICE FOR INCLUDING ENHANCING INFORMATION WITH PRINTED INFORMATION AND METHOD FOR ELECTRONIC SEARCHING THEREOF, executed on June 30, 1994, and in and to said U.S. Patent application and all applications that may be filed on said invention anywhere in the world, including any and all divisions, reissues, continuations and extensions thereof and in any Letters Patent, Inventors' Certificates, Design Registrations, Industrial Models, Utility Models and all other forms of protection that may be granted thereon worldwide, to Technology Innovations, LLC, a corporation organized under the laws of, and having its principal place of business in, the State of New York.

This Assignment includes, without limitation, all right, title, and interest in and to U.S. Patent No. 5,517,407, and further includes, without limitation, the exclusive right to sue and collect for all past, present and future infringement of one or more of U.S. Patent No. 5,517,407, and all other forms of protection that may be granted worldwide relating to the invention described in U.S. Patent Application Serial No. 08/269,920.

Technology Innovations, Inc., and its President, Michael L. Weiner, agree to fully cooperate in connection with any and all of the decisions or actions Technology

Innovations, LLC may make or take relating to the subject matter of this Assignment, including communicating any facts, signing lawful papers, and at the request of Technology Innovations, LLC or by other lawful process, testifying in any legal proceeding in connection therewith.


Regardless of when signed, this Assignment is effective on August 20, 1999, and the subject matter of this Assignment shall belong to Technology Innovations, LLC after the effective date.
