ASSIGNMENT

WHEREAS, We, Chanfeng Zhao, a United States citizen, residing at 10637 Gingerwood Cove, San Diego, CA 92130, Igor Kozlov, a Russian citizen, residing at 4671 Torrey Circle F304, La Jolla, CA 92130, and Galina Steinberg-Tatman, an Israeli citizen, residing at 5219 Setting Sun Way, San Diego, CA 92121, have invented certain new and useful improvements in METHODS OF ATTACHING BIOLOGICAL COMPOUNDS TO SOLID SUPPORTS USING TRIAZINE for which we have filed an application for Letters Patent in the United States, Application No. 11/271,433, filed on November 10, 2005.

AND WE DO HEREBY sell, assign, transfer, and convey to ASSIGNEE, its successors, legal representatives, and assigns all claims for damages and all remedies arising out of any violation of the rights assigned hereby that may have accrued prior to the date of assignment to ASSIGNEE, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of the said Letters Patent before or after issuance.

AND WE HEREBY covenant and agree that we will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
