The Assignors hereby agree, upon the request and at the expense of said Assignee, its successors and assigns, to execute any and all continuation,


continuation-in-part, divisional, extension, renewal, and substitute applications for said invention or improvements, and any necessary oath, affidavit or declaration relating thereto, and any application for the reissue, reexamination, or extension of any Letters Patent that may be granted upon said Applications, that said Assignee, its successors or assigns may deem necessary or expedient; and to cooperate to the best of the ability of the Assignors with said Assignee, its successors and assigns, in any proceedings or transactions involving such applications or patents, including the preparation and execution of preliminary statements, giving and producing evidence, and performing any and all acts necessary to obtain said Letters Patent in the United States and foreign countries, and vest all rights therein hereby conveyed in the Assignee, its successors and assigns, whereby said Letters Patent will be held and enjoyed by the said Assignee, its successors and assigns, to the full end of the term for which said Letters Patent will be granted, as fully and entirely as the same would have been held and enjoyed by the Assignors if this Assignment had not been made.


This Assignment shall be binding upon and shall inure to the benefit of the Assignee and Assignors and their respective successors and assigns.




