in favour of

ITW CS (UK) LIMITED incorporated under the Companies Acts (Registered Number 07073267) and having their Registered Office at Edinburgh Quay, 99 Gresham Street, London EC (the "Assignee")

the Assignor and the Assignee being hereinafter together referred to as "the parties".

WHEREAS:-

- (A) The Assignor is the proprietor of (and, where applicable the applicant for) the patents listed in the Schedule to this Assignment (the "Patents");
- (B) The Assignor is the beneficial owner of the patents and (patent applications) listed in the Schedule to this Assignment along with the know-how and copyright and design rights associated therewith (together the "Associated Rights"); and
- (C) The Assignor has agreed to assign its rights in the Patents and Associated Rights to the Assignee on the terms set out in this Assignment.

NOW HEREBY IT IS AGREED:-

1 INTERPRETATION

1.1 In this Agreement, unless the context otherwise requires:-

- a) use of the singular includes the plural and vice versa;
- b) use of any gender includes the other genders;
- c) reference to a "person" includes a natural person, firm, partnership, company, corporation, association, organisation, local or national governmental authority, state, foundation and trust (in each case whether or not having separate legal personality);
- d) reference to a person includes his legal representatives and permitted successors;
- e) reference to this Assignment or any other Agreement includes this Assignment or said other Agreement as amended, varied, supplemented or novated from time to time;
- f) reference to a clause, schedule, or part of a schedule is a reference to a clause, schedule, or part of a schedule of this Assignment; and
- g) any phrase introduced by the terms "including", "include", "in particular" or any comparable expression shall be construed as

illustrative only, and shall not limit and shall be without prejudice to the sense of the words preceding those terms.

- 1.2 The headings in this Assignment are included for convenience only and are to be ignored in its interpretation and construction.

2 **ASSIGNATION**

In consideration of payment of the sum of ONE POUND STERLING (£1), (receipt of which the Assignor hereby acknowledges) the Assignor hereby irrevocably assigns to the Assignee absolutely its whole right, title and interest past, present and future in the Patents including together with the Associated Rights:-

- a) the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of all infringements of any of the Patents, whether committed before or after the date of this Assignment;
- b) the absolute entitlement to any patents granted pursuant to any of the applications comprised in the Patents, for the full term of such patents; and
- c) the right to apply for, prosecute and obtain patent or similar protection in the UK and all other countries of the world for an invention embodied by any of the applications comprised in the Patents, including the right to claim priority from such applications.

3 **FURTHER ASSURANCE**

The Assignor hereby undertakes to the Assignee that the Assignor shall, at the expense of the Assignee, execute and sign all such instruments, applications and documents and do all such acts and things as may reasonably be required by the Assignee to enable the Assignee or its nominee to enjoy the full benefit of the rights assigned by this Assignment.

4 **GOVERNING LAW AND JURISDICTION**

- 4.1 This Assignment and any disputes or claims arising out of or in connection with its subject matter shall be governed by and construed in accordance with the law of Scotland which shall apply to the whole terms and provisions hereof.
- 4.2 The parties hereby irrevocably agree to submit to the non-exclusive jurisdiction of the Scottish courts so far as not already subject thereto.
