



ASSIGNMENT

WHEREAS I, Katherine White, Director of Cryovac Australia Pty Ltd, and Vice President, General Counsel, and Secretary of Sealed Air Corporation, on behalf of, and as agent for, Adrian M. Smith, who is named as the sole inventor of, but has refused to sign the Declaration and Power of Attorney for the invention disclosed and claimed in a patent application designated as USSN 12/460,435, filed in the United States Patent and Trademark Office on July 17, 2009, said application being entitled A Bag of A Heat-Shrinkable Gas-Barrier Thermoplastic Film, and who on 13 October 2008 signed a Deed of Acknowledgement stating that all right, title, and interest in said invention is vested in his employer Cryovac Australia Pty Ltd., with said 13 October 2008 Deed of Acknowledgement having been made of-record as Exhibit A accompanying the 11 December 2009 Statement of Facts filed in the United States Patent and Trademark Office in the file history of said USSN 12/460,435, and

WHEREAS CRYOVAC AUSTRALIA PTY LTD, a corporation organized and existing under the laws of Australia, and having a place of business at 1126 Sydney Road, Fawkner, Victoria 3060, Australia, is thereby the current owner of the entire right, title, and interest in and to said invention and in and to any Letters Patent that may be granted therefore, based on said Deed of Acknowledgement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, I, Katherine White, by these presents do sell, assign, and transfer from Cryovac Australia Pty Ltd to Cryovac, Inc., its successors and assigns the full, exclusive, and world-wide right to the said invention and the entire right, title, and interest in, to, and under any Letters Patent which may be granted therefor in the United States, in the territorial possessions of the United States, and in any country foreign to the United States, the same to be held and enjoyed by the said Cryovac, Inc., its successors and assigns as fully and entirely as the same would have been held by Cryovac Australia Pty Ltd us had this assignment and sale not been made.

And I do hereby authorize and request the Commissioner of Patents of the United States Patent and Trademark Office, and the Patent Office officials in countries foreign to the United States, to issue said Letters Patent to said Cryovac, Inc., as the assigns of our entire right, title, and interest in, to, and under the same, and I hereby further authorize said Cryovac, Inc. to apply for Letters Patent, as it in its sole discretion sees fit, utilizing any benefits which may exist under any International Arrangement, in any country foreign to the United States.

And I do hereby agree for myself and for my heirs, executors, and administrators to execute any lawful document and to testify as to any material fact or thing which Cryovac Inc., its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title, and interest in and to and the full enjoyment of said invention or any part therefor and the said Letters Patent or any of them, the same to be done without any further consideration.
