THIS PATENT ASSIGNMENT (this "**Assignment**") is made and entered into as of August 1, 2011 ("**Effective Date**") by and between **Pfizer Inc.**, a corporation organized under the laws of the state of Delaware, with its principal office at 235 East 42nd Street, New York, NY 10017 ("**Assignor**"), and **Capsugel Belgium BVBA**, a closed limited liability company, with its principal office at Rijksweg 11, 2880 Bornem, Belgium ("**Assignee**").

WHEREAS, Assignor and Chester Holdings S.a.r.l are parties to that certain Stock and Asset Purchase Agreement dated April 4, 2011 (the "**Purchase Agreement**"), pursuant to which Assignor has agreed to sell and Chester Holdings S.a.r.l has agreed to purchase the assets, rights and properties relating solely to the Business (as such term is defined in the Purchase Agreement);

WHEREAS, except as provided in Schedule A to this Assignment, Assignor is the sole and exclusive owner of the entire right, title and interest in, to and under those patents and patent applications identified and set forth on Schedule A (the "**Patents**"); and

WHEREAS, pursuant to Section 2.2(f) of the Purchase Agreement, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all right, title and interest in and to the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has sold, assigned, transferred, and conveyed, and does hereby sell, assign, transfer, and convey to Assignee its entire right, title and interest in and to the Patents, for the United States and for all foreign countries, including any inventions disclosed therein, and any continuations, continuations-in-part (but only to the extent the claims thereof are entitled to the benefit of the parent priority date), divisions, reissues, reexaminations, extensions or foreign equivalents thereof, and including the right to claim priority from said Patents under the Paris Convention for the Protection of Industrial Property, and under any and all other such treaties and agreements to which the United States is a party and which afford similar priority-claiming privileges, in all countries of the world, all Letters Patent or extension certificates which may be granted thereon for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all income, royalties, damages or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Patents, with the right to sue for, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives; and Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any foreign country whose duty it is to issue patents on applications as described above, to issue all Letters Patent for these inventions to Assignee, its successors and assigns, in accordance with the terms of this Assignment;


