**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENT RIGHTS**

TERMINATION AND RELEASE dated as of August 24, 2011 (this "Termination and Release"), from Banc of America Leasing & Capital, LLC, as successor-in-interest to Fleet Capital Corporation ("Lender"), with its principal place of business located at 555 California Street, 4th Floor, San Francisco, California 94104, to each of Rex International, Inc. f/k/a Rex-Rosenlew International, Inc. ("Rex") and Plassein International of Thomasville, Inc. f/k/a Rex International, Inc. ("Plassein"). Rex and Plassein are collectively referred to herein as the "Companies".

WITNESSETH:

WHEREAS, Lender and Rex entered into an agreement (the "First Security Agreement"), dated as of August 15, 2000, pursuant to which a security interest (the "First Security Interest") was granted by Rex to Lender in certain patents and applications (the "Rex Collateral");

WHEREAS, the First Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office ("USPTO") on November 14, 2000, at Reel 011306 and Frame 0928;

WHEREAS, Lender and Plassein entered into an agreement (the "Second Security Agreement"), dated as of May 14, 2003, pursuant to which a security interest (the "Second Security Interest") was granted by Plassein to Lender in the Rex Collateral and certain additional patents and patent applications (collectively, the "Plassein Collateral") (the First Security Interest and the Second Security Interest are collectively referred to herein as the "Security Interests");

WHEREAS, the Second Security Agreement was recorded with the USPTO on May 20, 2003, at Reel 014066 and Frame 0876;

WHEREAS, Plassein and Portsmouth Acquisition Co. ("PAC") entered into an agreement (the "PAC Assignment"), dated September 30, 2003, pursuant to which Plassein assigned the Plassein Collateral to PAC;

WHEREAS, the PAC Assignment was recorded with the USPTO on August 3, 2004, at Reel 014934 and Frame 0170;

WHEREAS, PAC changed its name to Exopack-Ontario, Inc. ("EOI") on October 1, 2003;

WHEREAS, PAC's name change to EOI was recorded with the USPTO on August 4, 2004, at Reel 014934 and Frame 0708;

WHEREAS, EOI and Exopack-Technology, LLC ("Exopack") entered into an agreement (the "Exopack Assignment"), dated July 23, 2004, pursuant to which EOI assigned the Plassein Collateral and certain additional patents and patent applications (the "Exopack Patents" as further defined below) to Exopack;

WHEREAS, the Exopack Assignment was recorded with the USPTO on August 2, 2004, at Reel 015629 and Frame 0230; and

WHEREAS, Lender now desires to terminate and release the entirety of its Security Interests in the Exopack Patents.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Exopack Patents pursuant to the First Security

Agreement and the Second Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Lender hereby states as follows:

1. Release of Security Interests. Lender hereby terminates, releases and discharges its Security Interests in all of the Companies' right, title and interest of every kind and nature in the patents and patent applications listed on Schedule A hereto (the "Exopack Patents"), and any right, title or interest of Lender in such Exopack Patents hereby ceases and becomes void.

2. Further Assurances. Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interests contemplated hereby.

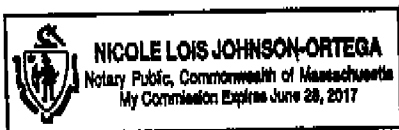
