CORRECTIVE ASSIGNMENT

WHEREAS, we, Thomas M. McCann, City of Raleigh, State of North Carolina; Petrus Wilhelmus Adrianus Jacobus Maria Nas, City of 's-Gravenhage (The Hague), Country of The Netherlands; Apirux Bantukul, City of Cary, State of North Carolina; Jeffrey A. Craig, City of Durham, State of North Carolina; and Peter J. Marsico, City of Chapel Hill, State of North Carolina (hereinafter "Assignors"), have invented certain new and useful improvements in METHODS, SYSTEMS, AND COMPUTER READABLE MEDIA FOR CENTRALIZED ROUTING AND CALL INSTANCE CODE MANAGEMENT FOR BEARER INDEPENDENT CALL CONTROL (BICC) SIGNALING MESSAGES (hereinafter, "Invention") for which application for a U.S. Patent was made on January 19, 2010 as Serial No. 12/689,702 (hereinafter, "Application").

AND, WHEREAS, Tekelec, a corporation duly organized and existing under the laws of the state of California, having its principal office and place of business at 5200 Paramount Parkway, Morrisville, North Carolina 27560 (hereinafter "Assignee"), is desirous of acquiring an interest therein.
