CORRECTIVE ASSIGNMENT

WHEREAS, we, Mark Edward Kanode, City of Apex, State of North Carolina; Mahesh Tomar, City of Morrisville, State of North Carolina; and Peter Joseph Marsico, City of Chapel Hill, State of North Carolina (hereinafter "Assignors"), have invented certain new and useful improvements in METHODS, SYSTEMS, AND COMPUTER READABLE MEDIA FOR PROVIDING PRIORITY ROUTING AT A DIAMETER NODE (hereinafter, Invention) for which application for a U.S. Patent was made on February 11, 2011 as Serial No. 13/026,060 (hereinafter, Application).


