NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Patapasco Designs, Inc. hereby sells, assigns, transfers and sets over to Circuit City Stores, Inc. Liquidating Trust, or its designee, all right, title and interest of Patapasco Designs, Inc. that exists today and may exist in the future in and to any and all of the Assigned Patent Rights.

Patapasco Designs, Inc. hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents, certificates of invention, utility models or other governmental grants or issuances that may be granted upon any of the Assigned Patent Rights in the name of Circuit City Stores, Inc. Liquidating Trust, as the assignee to the entire interest therein.

Patapasco Designs, Inc. will, at the reasonable request of Circuit City Stores, Inc. Liquidating Trust or its assignee, and without demanding any further consideration therefore, do all things necessary, proper, or advisable, including without limitation, the execution, acknowledgment, and recordation of specific assignments, oaths, declarations, and other documents on a country-by-country basis, to assist Circuit City Stores, Inc. Liquidating Trust or its assignee in obtaining, perfecting, sustaining, and/or enforcing the interests transferred hereunder. Such assistance will include providing, and obtaining from the respective inventors, prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, powers of attorney, specifications, declarations or other papers, and other assistance reasonably necessary for filing patent applications, complying with any duty of disclosure, and conducting prosecution, reexamination, reissue, interference or other priority proceedings, opposition proceedings, cancellation proceedings, public use proceedings, infringement or other court actions and the like with respect to such interests.

The terms and conditions of this Assignment will inure to the benefit of Circuit City Stores, Inc. Liquidating Trust, its successors, assigns (including IVS), and other legal representatives and will be binding upon Circuit City Stores, Inc. Liquidating Trust, its successors, assigns, and other legal representatives.
