ASSIGNOR hereby agrees to execute any papers, provide any information and testify in any interference or litigation at the request of ASSIGNEES, its successors, assigns and legal representatives, when deemed essential to ASSIGNEES', its successors', assigns' and legal representatives' full enjoyment, protection, enforcement and title in and to such invention and rights hereby transferred.

ASSIGNOR furthermore agrees upon request of said ASSIGNEES, its successors, assigns and legal representatives, and without further remuneration, to execute any and all papers desired by said ASSIGNEES, its successors, assigns and legal representatives, for the filing and granting of foreign applications and the perfecting of title thereto in said ASSIGNEES, its successors, assigns and legal representatives.
