RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS (this "Release") is made as of August 31, 2011 ("Effective Date") by GENERAL ELECTRIC CAPITAL CORPORATION, in its capacity as Agent for the Lenders ("Grantee"), in favor of SALIENT SURGICAL TECHNOLOGIES, INC. and SALIENT, INC. (collectively, "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement, dated as of May 8, 2009 (the "IP Security Agreement"), Grantors assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest in all of Grantors' right, title and interest in and to the Intellectual Property Collateral;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office with respect to trademarks on May 12, 2009 at Reel 003985, Frame 0709 and with respect to patents on May 12, 2009 at Reel 022668, Frame 0220;

WHEREAS, pursuant to the terms and conditions of that certain Supplement to Intellectual Property Security Agreement, dated as of September 17, 2010 (the "IP Supplement"), Grantors supplemented the list of Intellectual Property Collateral assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest in all of Grantors' right, title and interest in such additional Intellectual Property Collateral;

~~WHEREAS, the IP Supplement was recorded with the United States Patent and Trademark Office with respect to trademarks on September 28, 2010 at Reel 004285, Frame 0233 and with respect to patents on September 28, 2010 at Reel 025052, Frame 0412;~~

WHEREAS, pursuant to the terms and conditions of that certain payoff letter, dated as of [August __], 2011, by and among Grantee, Grantors and the other Loan Parties signatory to the Loan Agreement, Grantee has consented to the release of the Lien on the Intellectual Property Collateral, including, without limitation, all Intellectual Property Collateral listed on Schedules 1, 2, 3 and 4 hereto; and

WHEREAS, Grantee desires to release its Lien in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee's Lien in the Intellectual Property Collateral granted pursuant to the IP Security Agreement and IP Supplement is hereby terminated and released.
2. To the extent Grantee retains any such interest, Grantee hereby assigns, transfers and conveys to Grantors, all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Intellectual Property Collateral.

Such assignment, transfer and conveyance by Grantee is made without any representation or warranty (express or implied) by Grantee.

3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of Grantors.
