This matter came before the Court for approval without hearing pursuant to Minnesota Statute 518.13. The parties reached agreement on all matters. The parties entered into this Stipulated Judgment and Decree as their Marital Termination Agreement.

The parties reached settlement of all issues (Exhibit A) and the agreement was incorporated into this Stipulated Decree. The Court has reviewed the terms of the settlement, finds it to be fair and equitable and incorporates it herein by reference.

Based upon the parties' agreement, after duly considering the matter and upon all the files, records and proceedings herein, the Court hereby makes the following:

**FINDINGS OF FACT**

4. **Name Change.** Wife is seeking a name change from Molly Harney Minkkinen to Molly Harney solely because of this marriage dissolution and not to defraud or mislead anyone.

Wife affirms that she does not have a felony conviction for a crime under Minnesota law or the law of another state or federal jurisdiction.

5. **Irretrievable Breakdown.** There has been an irretrievable breakdown of the marriage relationship of the parties hereto pursuant to Minn. Stat. § 518.06, as amended.

6. **Residence.** Wife and Husband have both resided in the State of Minnesota for more than one hundred eighty (180) days, and they are now both residents of Lake County.

7. **Other Proceeding.** No separate proceeding for dissolution, legal separation, or custody is pending in a Court in this State or elsewhere.

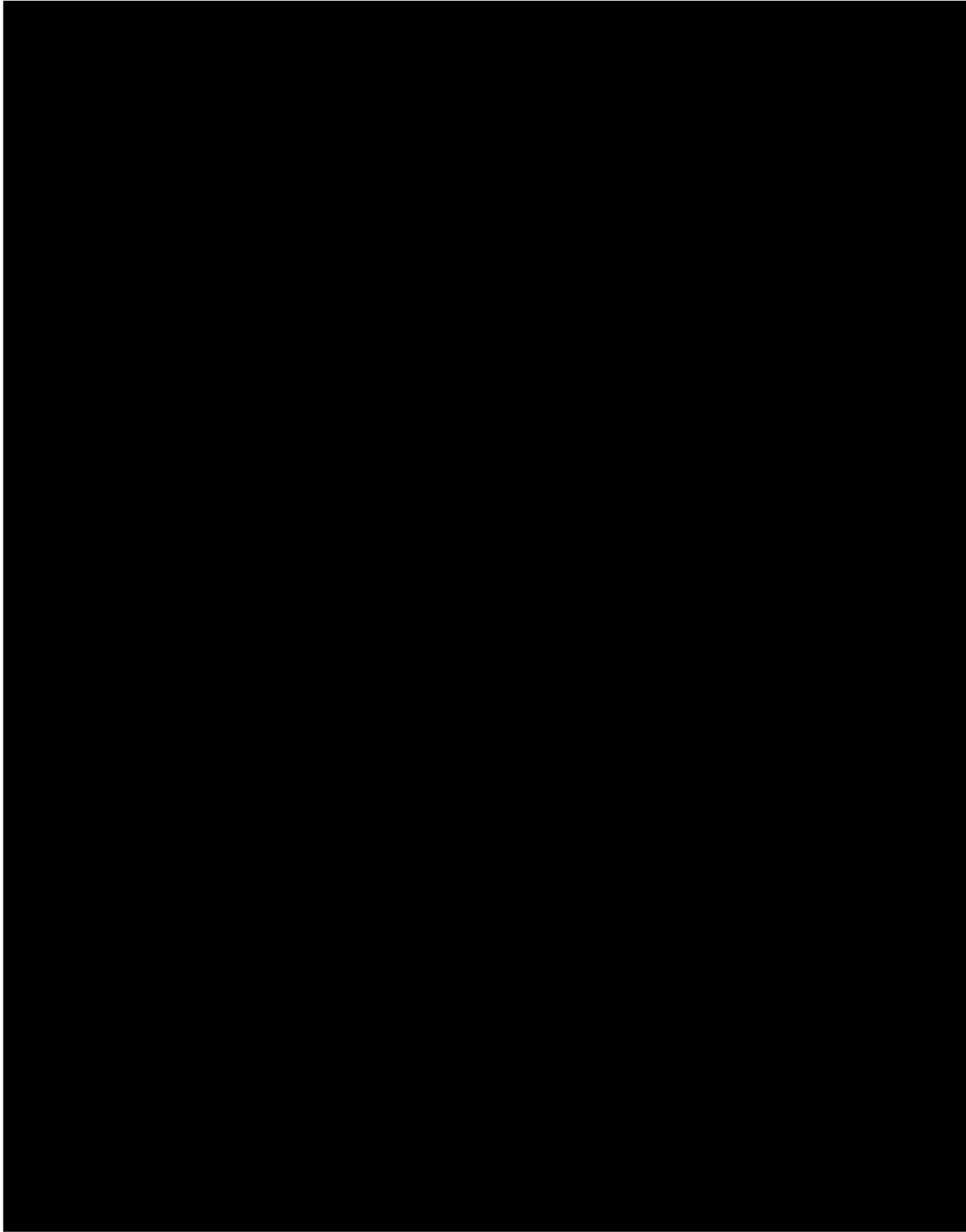
8. **Military Service.** Neither party is in the military service of the United States at any time which is relevant to this proceeding.

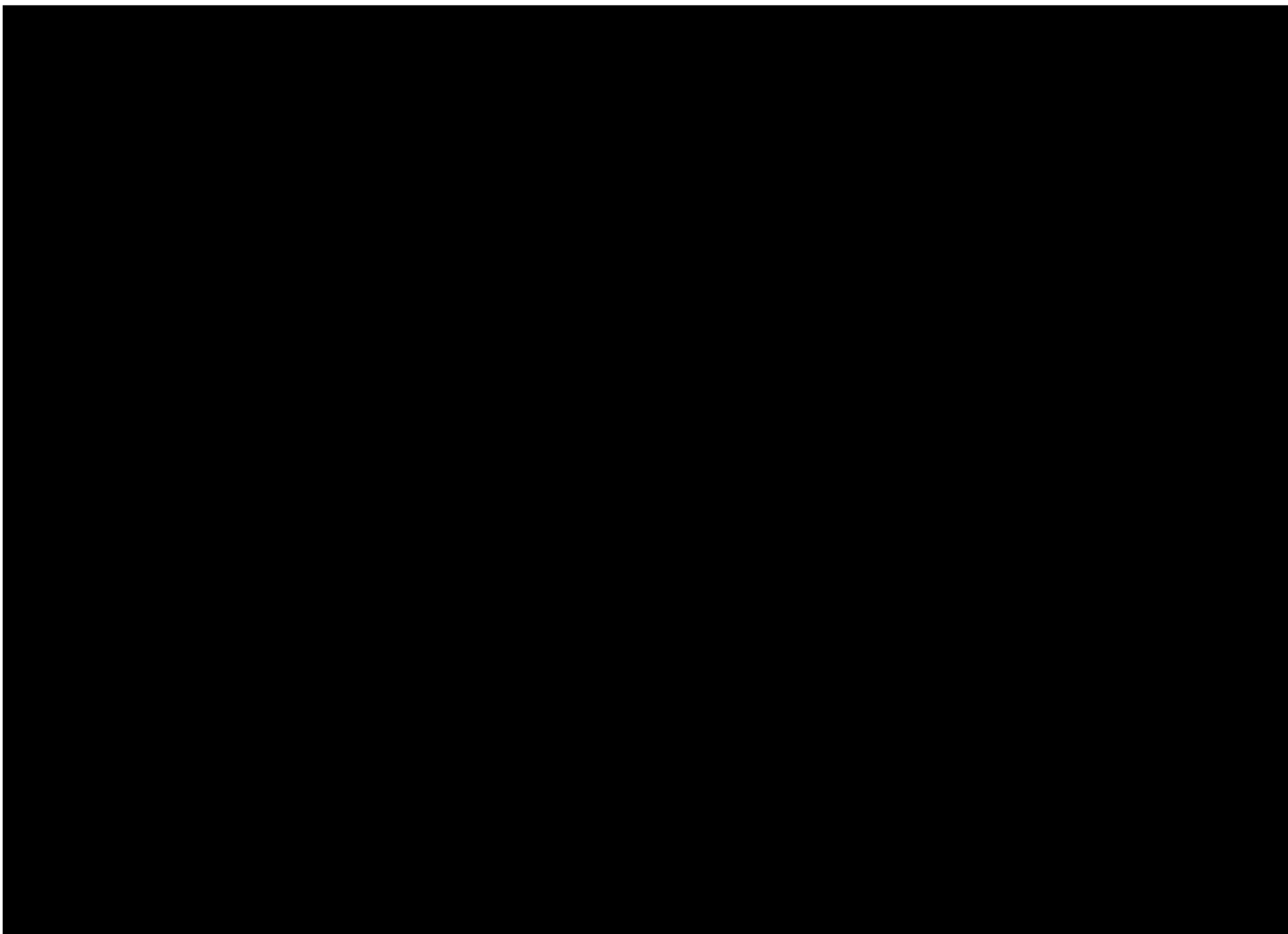
