(B) agrees upon request (and at the expense) of Assignee to, and if Assignor is unable or unwilling to do so authorizes Assignee to act in Assignor's name to: execute all oaths, assignments, powers, and any other papers necessary to perform Assignor's obligations hereunder, testify in any proceeding, and otherwise take any action, and fully cooperate with Assignee to perform Assignor's obligations hereunder, in each case, related to securing and enforcing Assignee's rights related to this Assignment.
