UNIVERSAL

WHEREAS, we, **Keith HUMPHRIES** whose full post office address is 7625 Borden Street, Vancouver, V5Z 1L3 (hereinafter referred to as the "**Assignor**"), have invented and created an invention entitled "Mutated HOXB4 proteins with improved stability, and methods of use thereof" and described in United States provisional patent application number 60/941,472, filed on June 1st, 2007, in United States patent application number 12/129,919, filed on May 30th, 2008 and in Canadian patent application number 2,590,593, filed on June 1st, 2007;


