ASSIGNMENT OF INVENTION

UNIVERSAL

WHEREAS, I, **Guy Sauvageau**, whose full post office address is 7390, rue de Tilly, Montreal, Québec, H3R 3E3, Canada and **Nathalie Beslu** (deceased), here legally represented by **Frederic Vincent**, the liquidator of the succession, whose full post office address is 5219 rue Cartier, Montréal, Québec, H2H 1X6, Canada (hereinafter referred to as the “**Assignors**”), have invented and created, in collaboration with two (2) other inventors, an invention entitled “Mutated HOXB4 proteins with improved stability, and methods of use thereof” and described in United States provisional patent application number 60/941,472, filed on June 1st, 2007, in United States patent application number 12/129,919, filed on May 30th, 2008 and in Canadian patent application number 2,590,593, filed on June 1st, 2007;

Assignors further agree, without any payment by said Assignees other than expenses incurred by the undersigned, to communicate to said Assignees, its representatives or agents, any facts relating to said invention, including evidence for interference purposes or for other proceedings,

whenever requested; testify in any interference, litigation or other proceedings, whenever requested; and execute and deliver, on request, all lawful papers required to make any of the foregoing provisions effective, and likewise make these provisions binding upon assignors' heirs, legal representatives, administrators and assigns.






