**WHEREAS**, We, the undersigned inventors, have made certain inventions or discoveries (or both) as set forth in an application for Letters Patent of the United States of America, entitled **Method and Apparatus for Mounting a Sheath onto the Distal End of a Surgical Shaft Instrument**, bearing U.S. Patent Application No. 13/193,161 and filed on July 28, 2011;

and discoveries or the history thereof; and to furnish Assignee with any and all documents, photographs, models, samples and other physical exhibits in our control or in the control of our heirs, legal representatives or assigns, which may be useful for establishing the facts of our conceptions, disclosures, and reduction to practice of said inventions and discoveries.
