## ASSIGNMENT

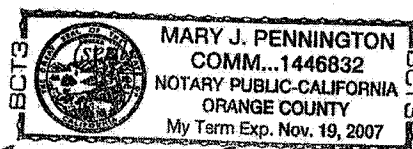

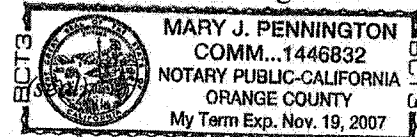
