ASSIGNMENT

WHEREAS I,

Ralf VAN DER VORST, residing at Chabotstraat 70, 4812 XP Breda, The Netherlands, am the sole designer of a design called ***Venetian blinds (part of -)*** for which design European Community Registered Design applications with serial numbers **001248272-001**, **001248272-002**, **001248272-003** and **001248272-004** were filed in the OHIM Office on **2 December 2010**, and I am entitled to assign my entire right, title and interest world-wide in and to the design and any intellectual property protection for the design, including the International Design application therefor; and

NOW THEREFORE, in consideration of the sum of one Euro (€1,00) and other good and valuable consideration, the receipt of which is acknowledged, I hereby sell, assign and transfer to the Company, its successors, legal representatives and assigns, my entire right, title and interest world-wide in and to the design and all applications for industrial property protection, including, without limitation, all applications for patents, utility models and designs, whether original, divisional, continuation, renewal, reissue, or the like, now on file or subsequently filed, for the design world-wide, together with the right to file such applications and the right to claim for such applications the priority rights derived from the International Design application under any national or international intellectual property laws or agreements and any industrial property protection including, without limitation, patents, utility models and designs, now or hereafter granted, for the design world-wide, and any extensions, renewals, reissues or the like thereof.

FURTHER I hereby authorize and request any official of any state, responsible for issuing patents or other evidence or forms of any industrial property protection, to issue the same for the design to the Company, its successors, legal representatives and assigns, in accordance with this assignment.

ALSO I hereby agree that I have the full right to convey my entire right, title and interest in and to the design world-wide and all applications for industrial property protection for the design world-wide and that I have not executed, and will not execute, any agreement in conflict with this assignment.




FURTHER I hereby agree that this assignment is to be considered effective as of the filing date of the International Design application.






