ASSIGNMENT

1. 5. Assignor hereby agrees to execute, without further consideration, any further documents deemed necessary by Assignee to fully secure its interest in the Patent Property.
6. Assignor covenants that Assignor has granted no right or license, to make, use or sell the Patent Property to anyone except Assignee; Assignor's right, title and interest in the

Patent Property has not been previously encumbered; and Assignor has not executed and will not execute any instrument in conflict herewith.

7. The Japanese patent application is serial number 2010-213347 and was filed on September 24, 2010 and identifies Toshinobu Hayakawa as the inventor(s), and was entitled Dialysis catheter.
