## ASSIGNMENT

WHEREAS WE, Frank Felten and Karl Bermes (hereinafter referred to as "ASSIGNOR") of Naurather Str. 3, Zemmer Germany 54313 and Auf'm Rothenhügel 2154666 Irrel Germany respectively, have invented certain new and useful improvements in:

FIRE EXTINGUISHER WITH A CONTAINER HOLDING A FIRE-EXTINGUISHING SUBSTANCE, AND

for which WE have filed an application for Letters Patent of the United States;

The undersigned declare that all statements made herein of his/her own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issuing thereon.
