# ASSIGNMENT

WHEREAS, I, Loren Taylor of 40 Dellwood Avenue, Chatham, New Jersey, hereafter the "Assignor", having invented certain new and useful improvements disclosed in a Patent Cooperation Treaty application to the United States Patent and Trademark Office entitled **POWDER DISPENSING APPARATUS** filed August 3, 2011 under application no. AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to Assignee any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all provisional, non-provisional, divisional, continuation, continuation-in-part, substitute, reissue, PCT, foreign, national phase, and all other applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.

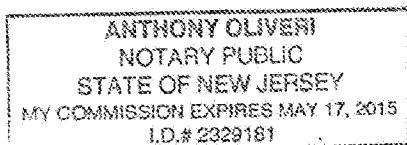
