AND ASSIGNORS HEREBY agree to communicate to Fox Valley or its representatives any facts known to us respecting said invention and/or Application, to execute all divisional, continuation, continuation-in-part, reexamination, reissue and foreign applications, sign all lawful documents and make all rightful oaths and declarations relating to said invention and/or Application, and to testify in any judicial or administrative proceeding and generally do everything possible to aid Fox Valley to secure full and complete protection for the invention and/or Application or that may be necessary to vest in Fox Valley the complete title to the invention and/or Application hereby conveyed and to enable it to record said title and enforce said letters patent in the United States of America or any foreign country when requested so to do by Fox Valley.

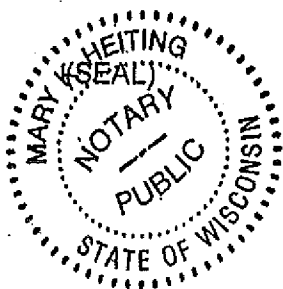

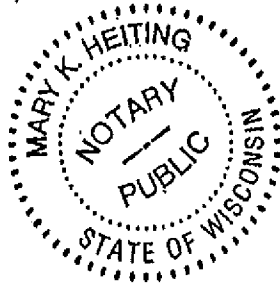
