Assignor will, at any time, upon request of Assignee, execute, acknowledge, and deliver all such further acts and deeds, assignments, instruments of transfer, or conveyance, registrations for assignments, powers of attorney, and assurances as reasonably may be required for the assigning, assuring, and confirming to Assignee, or to its successors and assigns, or for aiding and assisting in collecting and reducing to possession, the Patents, and any such other or further patent or application, which may relate to the Patents, assigned under this Patent Assignment. Assignor hereby irrevocably appoints Assignee as Assignor's attorney-in-fact to take such actions and make, execute, acknowledge and deliver all such documents as may from time to time be necessary to confirm the conveyance of all rights granted herein to Assignee, its successors and/or assigns. Assignor warrants to Assignee and to Assignee's successors and assigns that Assignor owns the Patent and has the full power and authority to make the foregoing assignment, and that it will not execute any documents or agreements that conflict with any rights or property assigned herein.

This Patent Assignment shall be binding upon the successors, assigns, nominees, or other legal representatives of Assignor.

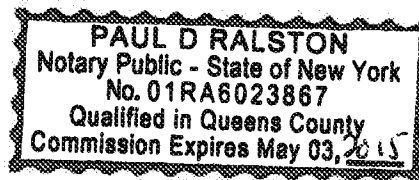
