AND the Assignors hereby agree, upon request, and without further consideration, but at the expense of the Assignee, to communicate to the Assignee or its representatives or nominees any facts known to them respecting the design and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths and generally aid the Assignee, its successors, assigns, and nominees to obtain and enforce proper design protection for the design in all countries, and the Assignors further agree to execute any and all further papers which may be necessary or desirable to vest or perfect the title of the Assignee, its successors and assigns, in and to the invention, and in and to any and all design registrations, or reissues, substitutions or prolongations thereof, which may be granted for the design in any and all countries in the world;




