

AND, for the same consideration, I specifically do sell, assign and transfer unto **Georgia Tech Research Corporation** all rights to sue for damages and other remedies for past infringement of any Letters Patent issuing from said application which may have occurred before the date of this assignment;

AND, for the same consideration, I agree, without charge to **Georgia Tech Research Corporation** but at its expense, to sign all lawful papers, execute all division, continuing, reissue and other applications, make all assignments and rightful oaths, and generally do everything reasonably possible to aid **Georgia Tech Research Corporation**, its successors, assigns, and nominees, to obtain and enforce proper protection for all said inventions and improvements in all countries throughout the world.
