
## PATENT APPLICATION ASSIGNMENT

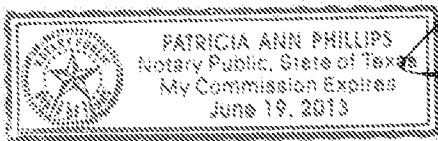


