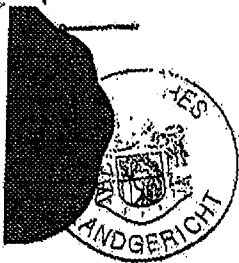

- on 15 December 2009, the company was migrated / continued to Saint Vincent and the Grenadines and was registered under number 1439 CTD 2009 under the name "Tenaris Connections Limited / Tenaris Connections AG".

As a matter of Saint Vincent and the Grenadines law,

(A) such registration did not operate to

- (i) create a new legal entity;
- (ii) prejudice or affect the identity or continuity of the company as previously constituted;
- (iii) prejudice or affect the property of the company;
- (iv) affect any appointment made, power conferred, resolution passed or any other act or thing done in relation to the company pursuant to a power conferred by any of the organizational documents of the company or by the laws of Liechtenstein; or
- (v) affect the rights, powers, authorities, functions and abilities or obligations of the company or any other person, and

(B) as from 15 December 2009, the company continues its corporate existence as a body corporate for all purposes as an international business company under and subject to the International Business Companies Act (Amendment and Consolidation Act) 2007 of Saint Vincent and the Grenadines; and

- since 15 December 2009, the company's registered address is 112 Bonadie Street, Kingstown, Saint Vincent and the Grenadines; and its European mailing address continues to be Bahnhofstrasse 7, POBox 48, 9494 Schaan, Liechtenstein.

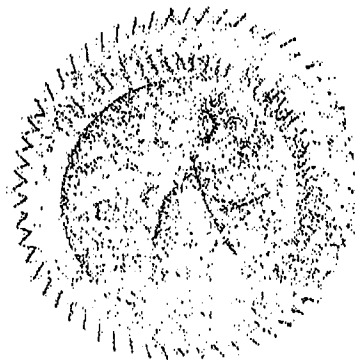


