Assignor also hereby confirms the sale, assignment, transfer, and conveyance unto Assignee, its successors and assigns, and hereby sells, assigns, transfers and conveys Nunc Pro Tunc to Assignee, its successors and assigns, the right to sue for any and all infringement of the patents, patent applications, and inventions set forth in Exhibit A occurring prior to the effective date of this Assignment.

Assigner further covenants and agrees, on its behalf and on behalf of its successors and assigns, that, at the request of the Assignee, Assignor will do all acts and things (including, without limitation, making declarations and oaths) and execute all documents that may be necessary for completing the transfer to Assignee of the full right, title and interest to any of the patents, patent applications, and inventions set forth in Exhibit A.

Assigner further covenants and agrees, on its behalf and on behalf of its successors and assigns, that, at the request of the Assignee, Assignor shall provide all assistance to the Assignee which may be necessary in connection with bringing or defending any proceedings relating to any of the patents, patent applications, and inventions set forth in Exhibit A.

This Assignment and any dispute or claim arising out of or in connection with it shall be governed by and construed in accordance with the laws of England and all disputes and claims arising out of or relating to this Assignment shall be subject to the exclusive jurisdiction of the English Courts to which the parties irrevocably submit.
