ASSIGNMENT

WHEREAS, I, John C. Redding of Oostburg, Wisconsin, have made certain joint inventions which are described in an application for Letters Patent of the United States entitled HANDLE ASSEMBLY FOR ROTATABLE STEM which was filed on January 25, 1996 and has been assigned Serial No. 08/591,067; and

I further grant to said Company, its successors and assigns, the right to claim for any of said applications the full benefits and priority rights of any international agreement between the United States and any foreign country or countries.

I hereby warrant that I have the full right to make the conveyance herein, and I hereby covenant that I, my heirs, legal representatives and assigns, will, when requested, communicate to said Company, its representatives, successors and assigns, all facts known respecting said inventions, execute all divisional, continuing, reissue, reexamination and foreign or international applications together with individual assignments therefor, make all rightful oaths, sign all lawful papers, testify in any legal proceeding and generally do everything possible to aid said Company, its successors and assigns, in the obtaining of Letters Patent.
