ASSIGNMENT OF SECURITY INTEREST IN PATENT COLLATERAL

WHEREAS, Assignor recorded the Patent Security Agreement with the United States Patent and Trademark Office on September 16, 2007, at Reel 019825, Frame 0532.

WHEREAS, pursuant to a Resignation and Appointment Agreement, dated as of September 30, 2011, Assignor assigned to Assignee, and Assignee assumed, all of Assignor's rights and obligations under the Security Agreement and the Patent Security Agreement and the liens granted thereunder.

WHEREAS, Assignor and Assignee desire to confirm the foregoing assignment and assumption in this Assignment for purposes of recording it with the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee, and Assignee hereby assumes, all of Assignor's right, title and interest in, to and under, the Patent Collateral and the Patent Security Agreement, including, without limitation, its lien on and security interest in Grantor's right, title and interest in to and under the Trademark Collateral. The foregoing Assignment is made without recourse, representations or warranties of any kind.
