## PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT (this "Assignment") is entered into and made effective this 27<sup>th</sup> day of May, 2011, by and between Safe Life Corp., a Delaware corporation ("Safe Life"), Triosyn Holding, Inc., a Canadian corporation ("Triosyn Holding"), and Safe Life / Triosyn Corp., a Delaware corporation (together with Safe Life and Triosyn Holding, collectively, the "Assignor"), on the one hand, and TrioMed Innovations Corp. (formerly known as "BioStar Innovations, Inc."), a Delaware corporation ("Assignee"), on the other hand.

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement dated as of May 6, 2011 ("Purchase Agreement") pursuant to which Assignor is transferring certain assets and liabilities of Assignor to Assignee; and

WHEREAS, the Purchase Agreement contemplates Assignor and Assignee entering into this Assignment in order to effectuate certain of the transfers contemplated by the Purchase Agreement in accordance with the terms and conditions set forth therein and herein.

NOW, THEREFORE, in consideration of one dollar (\$1.00) paid in hand and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby sells, assigns, transfers and delivers unto Assignee, its successors, legal representatives and assigns, all of Assignor's rights, title and interests in, to and under the patents and patent applications identified by title or the U.S., foreign, or international patent or patent application numbers, as applicable, listed on the attached Schedule A and all of the inventions claimed or otherwise disclosed therein (hereafter, collectively, the "Patents"), together with all provisionals, non-provisionals, divisions, renewals, requests for continuing examination, continuations, continuations-in-part, substitutions, international counterparts and foreign counterparts thereof, and all patents of the United States or of any other country which may be granted thereon and all reissues, reexaminations, renewals and extensions thereof; and all applications for industrial property protection, including without limitation all applications for patents, utility models, and designs which may be filed for any such inventions in any country, including without limitation in the United States and in countries foreign to the United States, together with the right to file such applications and the right to claim the priority rights or any other rights derived from any patents or patent applications described herein (including without limitation the Patents) under the patent laws of the United States or any other country, the Paris Convention for the Protection of Industrial Property, the Patent Cooperation Treaty or any other international agreement, treaty, law or convention, or the domestic laws of the country in which any such application is filed or patent has issued, as may be applicable; and all forms of industrial property protection, including without limitation patents, utility models, inventors' certificates and designs which may be granted for such inventions in any country, including without limitation in the United States and in countries foreign to the United States and all extensions, renewals, re-examinations and reissues thereof.

2. Assignor further sells, assigns, transfers, and delivers to Assignee all of Assignor's rights to sue or to bring any action or to assert any claim, whether at law or

in equity, against any third party relating to any of the Patents, including without limitation for past, present or future infringement, misappropriation, or other unauthorized use of any of the Patents, to obtain injunctive relief, and to recover or collect royalties, damages, and profits, including without limitation for such past, present or future infringement, misappropriation or unauthorized use of any of the Patents.

3. Assignor hereby authorizes and requests the Commissioner for Patents and any official of any country, including without limitation in the United States and in countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on any applications described herein, to issue the same to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this Assignment.

4. Assignor hereby covenants and agrees that it will not execute any agreement in conflict herewith.

5. Assignor hereby agrees to prepare, execute and deliver, or to cause to be prepared, executed and delivered, to Assignee, at Assignee's expense, such deeds, bills of sale, instruments of assumption, assignments, instruments of recordation, and other instruments, and take such other actions, in addition to those required by this Assignment, as Assignee may reasonably request in order to effect the intent and purposes of this Assignment (including without limitation the implementation and recordation of the transactions contemplated by this Assignment).

6. Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents as its agents and attorneys in fact, to act for and in its behalf and stead to execute and file any such documents and to do all other lawfully permitted acts to register, evidence or perfect Assignee's rights under this Assignment, including without limitation as required or contemplated by Section 5 hereof or by the Purchase Agreement, with the same legal force and effect as if executed by Assignor or any of its successors, legal representatives or assigns.
