## ASSIGNMENT

WHEREAS, Patricia Clare Belford and Ruth Ellen Morrow, both individuals and citizens of the United Kingdom, residing at 2a Irwin Avenue, Belfast, Northern Ireland BT4 3AF and at 1 Cregagh Park, Belfast, Northern Ireland BT6 9LF, respectively (hereinafter referred to as "Assignors"), have invented certain new and useful improvements in an **METHOD OF MANUFACTURE OF A COMPOSITE CONCRETE ARTICLE** for which an application for United States Letters Patent was executed on even date herewith, which claims priority from International Patent Application No. PCT/EP2010/001777, filed on March 22, 2010, which claims priority from United Kingdom Patent No. 0905951.0, filed on April 6, 2009.

Assignors hereby authorize and request the Patent Office Officials in the United States and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said Assignee as the owner of the entire right, title and interest in and to the same, for the sole use and behoof of said Assignee, its successors and assigns.





