## ASSIGNMENT

WHEREAS, WE, **Håkan Engqvist**, a citizen of Sweden, residing at Källörsgatan 6, 742 36 Östhammar, Sweden and **Jonas Åberg**, a citizen of Sweden, residing at Våktargatan 20B, SE-754 22 Uppsala, Sweden, (hereinafter referred to as "ASSIGNORS"), have invented "**Hydraulic Cements, Methods and Products**", as set forth in U.S. Non-Provisional Patent Application Serial No. 13/128,034, filed May 6, 2011, PCT Application No. PCT/IB2009/055042, filed November 12, 2009, and European Application No. 09760003.5, filed November 12, 2009; and


