Assignors request and authorize the Commissioner of Patents and Trademarks, US and its foreign counterparts, to issue the **LETTERS PATENT** when granted, in accordance with this assignment.

Assignor further covenants and agrees with the Assignee that Assignor has a full and unencumbered title to the invention, which title Assignors warrants to the Assignee. Assignors further agree that Assignor will, without demanding any further consideration therefor, at the request and expense of the Assignee, do all lawful and just acts, including the execution and acknowledgment of instruments, that may be or become necessary for obtaining sustaining, extending, reissuing or reexamining United States and foreign **LETTERS PATENT** or the like for the invention, and for maintaining and perfecting the Assignee's right to the invention and **LETTERS PATENT** particularly in cases of interference conflict, opposition and litigation.
