PATENT ASSIGNMENT

THIS ASSIGNMENT, by and between the Estate of Peter A. NOW, THEREFORE, be it known by all whom it may concern, that for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, the ESTATE hereby assigns, sells and sets over unto RELUME, its successors, legal representatives and assigns, for the territory of the United States of America and all foreign countries, the entire right, title and interest in and to said invention, and said PATENTS, including the right to file foreign patent applications corresponding to said PATENTS, and the right to claim the priority date of said PATENTS and any legal equivalents thereof, and any and all Letters Patent or Patents in the United States of America and all foreign countries which may be granted therefor and thereon, and to any and all divisions, continuations, and continuations-in-part of said application, or re-issues or extensions of said Letters Patent or PATENTS, the same to be held and enjoyed by RELUME, as fully and entirely as the same would have been held by the ESTATE had this Assignment and sale not been made.

AND the ESTATE hereby covenants and agrees that the ESTATE will at any time upon the request and at the expense of RELUME execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect the title to said PATENTS and to obtain Letters Patent therefor, and the ESTATE hereby authorizes and requests the U.S. Patent and Trademark Office to issue said Letters Patent to RELUME in accordance with this Agreement.
