The Assignor hereby agrees and acknowledges that it is the intent and effect of this General Patent Assignment that the Patent is transferred to Assignee, including, but not limited to the right to file and prosecute in its own name, wherever so permitted by law, patent applications, including corresponding applications, and to claim priority of patent applications, including corresponding applications, and to claim priority of patent applications pursuant to the Paris Convention or other such Treaties, and that Assignor shall, when requested by the Assignee, execute all rightful oaths, assignments, and powers of attorney, to the Assignee and to agents and legal representatives of the Assignee and all other papers necessary and proper to carry out the intent and purpose of this General Patent Assignment;

Assignor further authorizes any official of any country whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to record all

patents transferred hereunder and title thereto, as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this General Patent Assignment, and to issue the same to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.
