ASSIGNMENT

WHEREAS, I, LIUQING YANG, residing at 824 Huntington Hills Dr., Fort Collins, CO 80525, have invented certain new and useful subject matter for which an application for United States letters patent was:

I hereby authorize and request patent office officials in the United States and in all foreign countries to issue any patents in the Invention when granted to the Foundation as the assignee of my entire right, title, and interest in the patents.

I hereby assign to the Foundation, its successors and assigns, all of my rights to sue for and recover damages and profits arising from past infringements or unauthorized use of any patent that issues on the Invention or unpaid royalties with respect to use of any rights in the Invention occurring before the execution date of this Assignment.

I also agree that, in regard to the Invention, I will communicate to the Foundation or its representatives any facts known to me; testify in any legal proceedings; sign all lawful papers; execute all divisional, continuing, substitute, renewal, reissue, and other applications for letters patent; execute all necessary papers; make all rightful oaths; and generally do everything possible to aid the Foundation, its successors and assigns, to obtain and enforce proper protection for the Invention in the United States, its territorial possessions, and all foreign countries.
