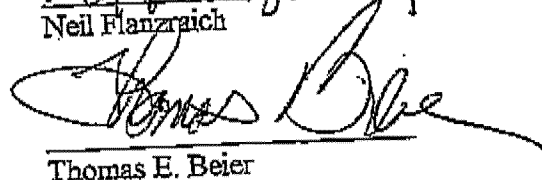
The name of the corporation is "TVAX LABORATORIES, INC." (hereinafter called the "Corporation").
