ASSIGNMENT

WHEREAS, DAVID LEE residing at 3418 PALM BAY CIRCLE, SEABROOK, TX 77586; ADAM OROSCO, residing at 2107 VILLAGE DALE AVENUE, HOUSTON, TX 77059; LINCOLN SARAGER residing at 16110 LA CABANA DRIVE, HOUSTON, TX 77062; and VICTOR J. JOHNSTON residing at 3234 PLEASANT COVE COURT, HOUSTON, TX 77059 (hereinafter referred to as ASSIGNORS), have invented certain new and useful improvements in REDUCING ACETALS AND/OR ESTERS DURING ETHANOL SEPARATION PROCESS (hereinafter referred to as THE INVENTION) for which an application for United States Letters Patent was filed on August 3, 2011, as Serial No. 13/197,699.

ASSIGNORS also agree, without further consideration and at ASSIGNEE's expense, to identify and communicate to ASSIGNEE at ASSIGNEE's request documents and information concerning the invention that are within ASSIGNOR's possession or control, and to provide further assurances and testimony on behalf of ASSIGNEE that lawfully may be required of ASSIGNORS in respect of the prosecution, maintenance and defense of any patent application or patent encompassed within the terms of this instrument.

ASSIGNORS also agree, without further consideration and at ASSIGNEE's expense, to transfer the right to sue for past infringement to ASSIGNEE and at ASSIGNEE's request documents and information concerning the enforcement of the right to sue within ASSIGNORS possession or control, and to provide further assurances and testimony on behalf of ASSIGNEE that lawfully may be required of ASSIGNOR in respect of the right to sue of any patent encompassed within the terms of this instrument.

ASSIGNORS' obligation under this instrument shall extend to ASSIGNOR's heirs, executors, administrators and other legal representatives.

ASSIGNORS hereby grant the firm of Roberts Mlotkowski Safran & Cole the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.

ASSIGNORS hereby authorize and requests the Commissioner of Patents and Trademarks to issue any and all United States Letters Patent referred to above to ASSIGNEE of the entire right, title and interest in and to the same, for ASSIGNEE's sole use and behalf; and for the use and behalf of ASSIGNEE's legal representatives and successors, to the full end of the term for which such Letters Patent may be granted, as fully and entirely as the same would have been held by ASSIGNORS had this assignment and sale not been made.

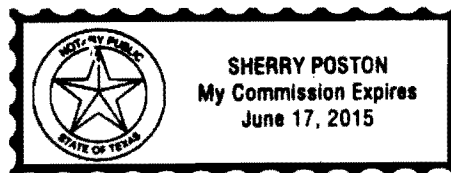

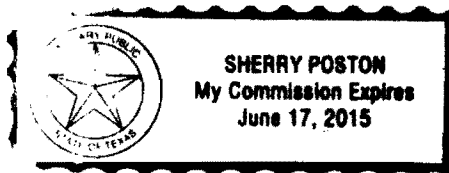
