application, was employed in the U.K. as a handbag designer by Stella McCartney Limited as of June, 2007, reporting directly to Ms. Stella McCartney. As a condition of her employment, all intellectual property arising from any work undertaken by Ms. Orilland in the course of her employment was to be the property of Stella McCartney Limited. The handbag design that is the subject of the above application was designed by Ms. Orilland in June of 2009 in the course of her employment with Stella McCartney Limited. Ms. Orilland left the employ of Stella McCartney Ltd. later in 2009.

After the above application was filed on April 23, 2010, Stella McCartney, Ltd. made attempts to contact Ms. Orilland by telephone and mail at the address then thought to be her most recent address requesting her assistance. Upon further inquiry, in September of 2010, Applicant determined that Ms. Orilland's most recent address to be:

49 Belsize Avenue, London, NY3 4BN, United Kingdom

Further attempts to contact Ms. Orilland at this address were unsuccessful. Applicant retained an investigator to visit this address and to make further inquiries about the possible whereabouts of Ms. Orilland. The report of the investigator is attached as an exhibit to Ms. Newman's Declaration. The report relates that during a site visit to Ms. Orilland's last known address on September 29, 2010, the current occupant of her apartment informed the investigator that Ms. Orilland no longer lived at the address and that she had moved out "four to five months ago." No forwarding address was available.

According to the report, the investigator also searched database sources, including election rolls, registered phone numbers, Land Registry details, consumer information and credit history and could find no current references for Estelle Orilland. An election roll search revealed

an Estelle Orilliano residing at the 49 Belsize Avenue address as of 2008, but had no other current information or forwarding address.

Applicant's ownership of the design is established under U.K. law, as is shown by the Declaration Regarding Legal Ownership attached at Exhibit C and signed by Ms. Helen Newman, a practicing U.K. solicitor and partner at the firm of Olswang, LLP. The Copyright, Designs and Patents Act 1988 provides in part (I) section 11 that the first owner of a copyright in a design is the author of that work save where that work is made by an employee in the course of his or her employment. The position with regard to unregistered design right is similar. In this case reference has to be made to section 215 of the Copyright, Designs and Patents Act 1988 in part (II) of the act. Copies of the relevant sections are attached to the Declaration Regarding Legal Ownership. Under this controlling law, the employer is the first owner of intellectual property rights in the work subject to any agreement to the contrary.

In the course of its handbag designing operations, Gucci Group provides human resources services on behalf of Stella McCartney, Ltd. These services include the administration of the contracts of employment of employees of Stella McCartney Limited. Insofar as under U.K. law any of the design rights to the subject handbag design would be deemed to be held by Gucci Group, it is the intention of both Gucci Group and Stella McCartney Limited that such rights would be owned by Stella McCartney Limited. Gucci Group has accordingly confirmed this position by providing a signed assignment of any rights it may have acquired and was holding in trust for Stella McCartney Limited, in the intellectual property of the handbag design created by Ms. Orilland that is the subject of the application referenced above (see copy attached at Exhibit D). Therefore, ownership, whether by operation of law or by assignment, in Stella McCartney Limited is established.

I, Helen Newman, the undersigned, declare as follows:

1) I am a director of Stella McCartney Limited, and have first hand knowledge of the following

facts.

2) Estelle Orilland, inventor of the design which is the subject of the current application, was

employed in the U.K. as a handbag designer by Stella McCartney Limited as of June, 2007,

reporting directly to Ms. Stella McCartney the creative director of Stella McCartney Limited.

3) Stella McCartney Limited is a company which is owned jointly by Ms McCartney and Gucci

Group and Gucci Group provide various services to Stella McCartney Limited including human

resources services. These services include the administration of the contracts of employment of

employees of Stella McCartney Limited.

4) Ms Orilland was employed as a full time designer under a contract with Stella McCartney

Limited and she was also provided with an Employee Handbook, that stated, in part, that any

intellectual property in any designs she created or worked on in the course of her employment

would be owned by Gucci Group.

5) In fact the intention of both Gucci Group and Stella McCartney Limited was that any

intellectual property in designs created by Ms. Orilland would be owned by Stella McCartney

Limited. Gueci Group has accordingly confirmed this position by providing a form of



1. Instructions

We were asked to establish whether Estelle Orilland is still resident at the following address:

If we found that she was not at the above address we were to try and obtain a forwarding address.

2. Summary

We conducted a site visit to Flat 6, 49 Belsize Avenue and were informed by the current occupant that Estelle Orilland left the property approximately four or five months ago. We were also told that there is no forwarding address for her.

Despite Electoral Roll, consumer information checks and database searches we can find no current address for Estelle Orilland.

3. Investigation

a) Database Searches:

We have obtained the following information using a combination of data sources in the public domain and restricted access databases. This information can include past and present Electoral Roll records, registered telephone numbers, Land Registry details and credit history. We cross check each piece of information as far as possible in order to verify its accuracy.

We conducted Electoral Roll and consumer information checks on restricted access databases for ESTELLE ORILLAND and found no positive results.

We therefore conducted Electoral Roll and consumer information checks on restricted access databases for Flat 6, 49 Belsize Avenue, London NW3 4BN. We found there was an Electoral Roll record for ESTELLE ORILLANO at 49 Belsize Avenue. Please see below for more details:

Liberal Opinions contains young, professional people who have benefited from a university education. Interested in exploring the worlds of people different from themselves, this group often throw themselves into the type of professional job where there is no clear boundary between work and leisure. For this reason it is often more convenient as well as more attractive for them to live in accessible inner suburbs.

Urban Cool are a diverse mix of people at different stages of their life but who are mostly on a good income. It is the diversity and vibrancy that attracts wealthier residents to these neighbourhoods. Very often, streets contain a mix of quite spacious houses, most of which are owner occupied but some still in multiple occupation, and converted flats, some of which are owner occupied and others rented. Neighbourhoods of this sort are common throughout inner London.

Given the above we conducted a search of the Land Registry for Flat 6, 49 Belsize Avenue (which is listed as the third flat (front)). We obtained the leasehold for this property which does not mention ESTELLE ORILLAND. Please see below:

We proceeded to conduct a search for ESTELLE ORILLAND/ESTELLE ORILLANO on the Companies House register. According to the official register there are no records of a director or secretary with this name. Furthermore, we found no records under Resigned, Dissolved or Disqualified Appointments.

We therefore conducted a telephone directory enquiry for "ESTELLE ORILLAND" at Flat 6, 49 Belsize Avenue. We were told by the representative that there was no listing for this individual at that address.

We conducted an "address verification" on the N2 database and found no other addresses or aliases for ESTELLE ORILLAND.

We therefore conducted a number of individual tracing database searches to try and obtain another address for ESTELLE ORILLAND. We found no such address.

b) Site Visit:

At 8:41hrs we conducted a site visit to 49 Belsize Avenue, London, NW3 4BN. The building is secure and admission is gained through an intercom, with buzzers for each of the flats inside.

We rang the buzzer for Flat 6, which was answered by an unidentified man. We asked if Estelle Orilland was in, and he replied that she no longer lived at the address. We asked how long ago she had moved out, and he said about four or five months ago. We asked if there was a forwarding address and he said that he did not have one. He was suspicious and asked why we were asking after her, and we explained that we had a delivery for her and would return it to the sender.

The man would not give his name and we left the property.

Stella McCartney Limited - Application for registration of a design patent

This letter and opinion considers the position under English law with regard to the ownership of copyright and design right in the design that is the subject of European community design application nos. 001628165-0001 and 001628157-001 filed on 26 October 2009 ("the Design"). The Design is also the subject of a US design patent application (U.S. Application Serial No. 29/349,698) which claims priority to the European community design applications just referred to.

History of the Creation of the Design

The Design was created by an individual, Estelle Orilland, who at the time of the creation of the design was a full time employee of Stella McCartney Limited ("SML"), a company incorporated in England and Wales and based in England. The Design was created in 2009 and Ms. Orilland's employment commenced in 2007.

Copyright and Design Right

In England, copyright and design right are regulated by an Act of Parliament, namely the Copyright Designs and Patents Act 1988 (as amended) ("CDPA"). The design in question was embodied in a sketch created by Ms. Orilland during the course of her employment as a handbag designer. For the purposes of copyright law in England, a sketch of an article of this type constitutes 'an artistic work' and copyright subsist in original artistic works.

We use the word partner to rater to a member of Classing LLP, or an employee or compalated of Classing LLP or any of its affiliated treatments with experience and extensions, and qualifications.

Section 1 of the CDPA provides that:

"Copyright is a property right which subsists...in the following descriptions of work -

(a) original literary, dramatic, musical or artistic works."

Under Section 4 'artistic works' are defined to mean:

"(a) a graphic work...irrespective of artistic quality."

Section 4 of the CDPA goes on to define a 'graphic work' as including:

"(a) any painting, drawing, diagram, map, chart or plan."

Ms Orilland's sketch also qualifies as a 'design' and under CDPA design right also exists in the Design.

Section 213 of the CDPA describes design right as a "property right which subsists...in an original design" and a 'design' is defined to mean:

"the design of any aspect of a shape or configuration (whether internal or external) of the whole or part of an article."

Ownership of Copyright and Design Right

So far as copyright is concerned, the CDPA provides that the first owner of any copyright in an artistic work is the author of that work subject to an important qualification in Section 11 (2). This provides:

"where a...artistic work is made by an employee in the course of his employment, his employer is the first owner of any copyright in the work subject to any agreement to the contrary."

The position is similar in relation to design right where Section 215 of the CDPA provides that the designer is the first owner of any design right in a design which is not created in the course of employment and subsection 3 provides:

"where...a design is created by an employee in the course of his employment, his employer is the first owner of any design right in the design."

In the current circumstances, the position prima facie is that both copyright and design right in the Design belong to Ms. Orilland's employer, namely SML, subject to any agreement to the contrary.

Rights Held in Trust

Following her employment by SML, Ms. Orilland was given an Employee Handbook detailing a number of provisions relating to her employment by SML. This document included a provision

which indicated that any intellectual property rights created by her during the course of her employment would be owned by Gucci Group. Gucci Group is a 50% shareholder in SML.

The Employee Handbook was intended to form part of Ms. Orilland's contract of employment. As such, the reference to Gucci Group in this document is inconsistent with the employment of Ms. Orilland by SML. To the extent, therefore, that the Employee Handbook constitutes "an agreement to the contrary" for the purposes of CDPA, it is arguable that some interest in the copyright and design right in the Design may have vested in Gucci Group.

The rights in the Design have been exploited by SML and we are informed that Gucci Group have confirmed that the intention was at all times that any intellectual property in designs created by Ms. Orilland would be owned and exploited by SML and that in so far as any rights in respect of the Design may have vested in Gucci Group, those rights have been held in trust for SML. For the avoidance of any doubt, a form of assignment has been executed to ensure that any such rights in the Design held by Gucci Group have been transferred to SML.

This letter summarises our understanding of the facts and the legal analysis. In so far as any rights may have been held by Gucci Group N.V. in the Design, these were held in trust for SML and have, in any event, been assigned to SML.
