INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this "Agreement") is entered into by and between Shibasoku Co., Ltd., a Japanese corporation, with a principal place of business at 4-6-8 Shinbashi, Minato-ku, Tokyo 105-004, Japan ("Assignor") and Jonathan R. Goldsmith, Chapter 7 Trustee of the bankruptcy estate of Asterion, Massachusetts Chapter 7 Case No. 10-41165-HJB ("Assignee").

WHEREAS, Assignor claims it is the owner of the entire right, title and interest in and to the inventions disclosed in the United States and Foreign Patent Applications, filed and unfiled, and the United States and Foreign patents incorporated herein by reference as Exhibit A, and in and to such patents and applications;

WHEREAS, Assignor claims it is the owner of all right, title and interest in and to all intellectual property assigned to it by Asterion, Inc. pursuant to an intellectual property assignment agreement between Asterion, Inc. and Assignor dated March 4, 2010 (Attached hereto as Exhibit B) including, but not limited to patents and patent applications listed on Exhibit A, trademarks, service marks, corporate names, trade names, slogans, brand names, logos, internet domain names, copyrights, trade secrets, confidential information, know-how, inventions, rights residing in software, mechanical drawings, electrical schematics, assembly drawings, test procedures, benchmark data and any applications and registrations relating to the so-called SMX Tester or used by Asterion, Inc.

WHEREAS, Assignee is desirous of acquiring an assignment of Assignor's entire right, title and interest in and to the intellectual property referenced in the preceding paragraphs and in Exhibits A & B (such intellectual property referred to collectively as the "Assigned IP");

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged:

1. **Assignment** Assignor has sold, assigned and transferred, and by these presents does hereby sell, assign and transfer to Assignee, its successors and assigns, Assignor's entire right, title and interest in and to such inventions, such patent applications, filed and unfiled, and such patents listed on Exhibit A and any patents and any reissues and extensions thereof, which issue or have issued in any country upon patent applications which correspond with or claim priority from any such applications or patents, divisional, continuation in whole, or continuation-in-part thereof, including the right to sue and collect for past infringements; the same to be held and enjoyed by Assignee for its own use, and for the use of its legal representatives, to the full term for which such patents have been granted as fully and entirely as the same would have been held by Assignor had this assignment not been made.


In addition, for good and valuable consideration, receipt of which is hereby acknowledged, **Assignor** has sold, assigned and transferred, and by these presents, does hereby assign and transfer to **Assignee**, its successors and assigns, all **Assignor's** right, title and interest in and to all intellectual property assigned to it by Asterion, Inc. pursuant to an intellectual property assignment agreement between Asterion, Inc. and **Assignor** dated March 4, 2010 (Attached hereto as Exhibit B), or any other agreement or instrument between **Assignor** and Asterion, Inc. assigning Asterion, Inc. intellectual property to **Assignor**, including, but not limited to patents and patent applications, trademarks, service marks, corporate names, trade names, slogans, brand names, logos, internet domain names, copyrights, trade secrets, confidential information, know-how, inventions, computer software and rights residing in software, mechanical drawings, electrical schematics, assembly drawings, test procedures, benchmark data and any applications and registrations relating to the so-called SMX Tester;

2. **Further Assurances.** **Assignor** represents that prior to this Agreement **Assignor** has not assigned or transferred to any person or entity any of the right, title or interest in the Assigned IP that **Assignor** ever may have had in and to the Assigned IP, and that **Assignor** has no knowledge of any other person or entity having a claim to a right, title or interest in the Assigned IP other than Asterion, Inc. or the **Assignee**.
3. **Governing Law.** This assignment and Agreement shall be governed by, and construed and interpreted in accordance with the laws of the Commonwealth of Massachusetts applicable to agreements made and to be performed entirely within such a state, including all matters of construction, validity and performance.
4. **Binding Effect.** The terms and covenants of this Agreement shall inure to the benefit of the **Assignee**, its successors, assigns and other legal representatives, and shall be binding upon **Assignor**, its successors, assigns and legal representatives.

5. **Counterparts.** This Agreement may be executed in any number of counterparts, each of which shall be an original, but all of which shall constitute one instrument.

INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Agreement") is entered into by and between Asterion, Inc., a Massachusetts corporation, with its principal place of business at 450 Donald J. Lynch Blvd., Marlborough, Massachusetts 01752 ("Assignor"), and Shibasoku Co., Ltd., a Japanese corporation, with its principal place of business at 4-6-8 Shinbashi, Minato-ku, Tokyo 105-004, Japan ("Assignee").

WITNESSETH:

WHEREAS, pursuant to that certain Services Agreement, dated March 1, 2004 (the "Services Agreement"), that certain License Agreement, dated September 1, 2006 (the "License Agreement"), and that certain Termination of Service Agreement dated February 4, 2009 (the "Termination Agreement") (the Services Agreement, the License Agreement and the Termination Agreement are collectively referred to herein as the "Prior Agreements"), Assignor agreed to assign and did assign to Assignee all the current and future intellectual property created, developed and/or otherwise acquired by Assignor under and in connection with the Services Agreement, including, but not limited to: (i) the so-called SMX Tester (including any components, parts, software, updates, upgrades, developments, improvements and maintenance, repair and other services related thereto); (ii) all patents, trademarks, service marks, corporate names, trade names, slogans, brand names, logos, Internet domain names, copyrights, trade secrets, confidential information, know-how, inventions, rights residing in software, any applications and registrations for any of the foregoing and all other intellectual property and/or proprietary rights now known or hereafter recognized in any applicable jurisdiction ("Intellectual Property Rights") embodied therein; (iii) all Intellectual Property Rights developed under the Services Agreement and all Intellectual Property Rights developed from and after the termination of the Services Agreement based on such Intellectual Property Rights; and (iv) all improvements and Intellectual Property rights therein developed and created by Assignor based on the SMX Tester or using the Intellectual Property Rights developed or created under the Services Agreement or otherwise paid for by Assignee during the term of the License Agreement (all of the foregoing are collectively referred to herein as the "IP").

WHEREAS, Assignor, in its own name, filed the patent applications and/or obtained the patents listed in Exhibit A (the "Patents"), which Patents are currently in the name of Assignor; and

WHEREAS, the parties desire, by this confirmatory Intellectual Property Assignment Agreement, to confirm the prior assignment of all of the IP, including but not limited to the Patents, to Assignee under the Prior Agreements for the purposes of confirming the assignment and to permit Assignee to record its ownership of the Patents and other IP, as applicable.

NOW, THEREFORE, for consideration of One Dollar (US\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Assignment. Assignor confirms the assignment of, and hereby does sell, assign, transfer, and convey to Assignee and its successors, assigns, and nominees, nunc pro tunc,

absolutely and in perpetuity, Assignor's entire right, title, and interest worldwide in and to the IP and all goodwill associated therewith, including but not limited to: (i) the entire right, title, and interest in and to the inventions described in the applications for such IP in any form or embodiment thereof (including, but not limited to, the Patents listed in Exhibit A); (ii) patent applications filed in any country based thereon; (iii) patent applications filed under the provisions of any applicable international treaty; (iv) any and all patents or reissues or extensions thereof to be obtained in any country upon said inventions and any divisional, continuation, or substitute applications that have been filed or may be filed upon said invention or inventions in any country; and (v) the right to sue for and receive all damages from past infringements of the IP arising prior to the date of the last signature to this Agreement, the same to be held and enjoyed by Assignee, its successors, assigns, and legal representatives.

2. Further Assurances. Assignor further agrees to execute all documents and do all such other things as may be necessary or appropriate to carry out the intent and/or purpose of this Agreement. In addition, and without limiting the generality of the foregoing, Assignor further agrees, at the request of Assignee or its successors in interest, to do all lawful acts which may be required for obtaining and enforcing the intellectual property rights in the IP, and to otherwise aid assignee or its successors in interest in enforcing intellectual property rights in the IP, all at the expense of Assignee or its successors in interest.

3. Power of Attorney. Assignor hereby constitutes and appoints Assignee and its successors and assigns as Assignor's true and lawful attorneys with full power of substitution, in Assignor's name and stead but on behalf and for the benefit of the Assignee and its successors and assigns, to demand and receive any and all of the IP and to give receipts and releases for and in respect of the same, and any part thereof, and from time to time to institute and prosecute, at the expense and for the benefit of the Assignee and its successors and assigns, any and all proceedings at law, in equity or otherwise, or to execute such documents, which the Assignee or its successors or assigns may deem proper for the collection or reduction to possession of, or recordation of ownership to, any of the IP, or for the collection and enforcement of any claim or right of any kind hereby sold, conveyed, transferred and assigned, or intended so to be, and to do all acts and things in relation to the IP which the Assignee or its successors or assigns shall deem desirable. The foregoing powers are coupled with an interest and are and shall be irrevocable by the Assignor or by dissolution of the Assignor or in any manner or for any reason whatsoever.

4. Governing Law. This Agreement shall be governed by, and construed and interpreted in accordance with the laws of the State of Massachusetts applicable to agreements made and to be performed entirely within such state, including all matters of construction, validity and performance.

5. Binding Effect. The terms and covenants of this Agreement shall inure to the benefit of Assignee, its successors, assigns, and other legal representatives, and shall be binding upon Assignor, its successors, assigns, and legal representatives.




