2. Article I of the Articles of Incorporation of this corporation is deleted in its entirety and replaced with the following:

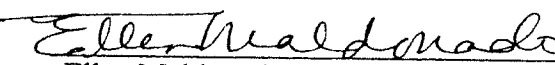
"ARTICLE I

The name of the corporation is Arysta LifeScience North America Corporation."

3. The foregoing amendment of the Articles of Incorporation has been duly approved by the directors of this corporation.
4. The foregoing amendments of the Articles of Incorporation has been duly approved by the required vote of the shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the corporation entitled to vote with respect to the amendment is 5,213,246 shares of common stock.
