## ASSIGNMENT AND AGREEMENT

I request that any and all patents for said inventions be issued to **Nexans** in the United States and in all countries foreign to the United States, or to such nominees as **Nexans** they may designate.

I agree that, when requested, we shall, without charge to **Nexans**, but at its expense, sign all papers and do all acts which may be necessary, desirable or convenient in connection with said applications, patents, or other forms of protection.
