WITNESSETH: That,

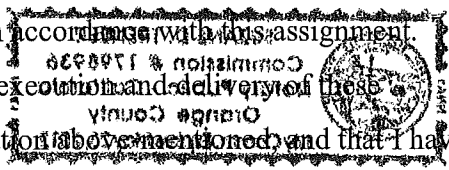
