**QUITCLAIM ASSIGNMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby further acknowledges that ASSIGNOR has quitclaimed, sold, assigned, and transferred, and by these presents does hereby quitclaim, sell, assign, and transfer, unto ASSIGNEE, its successors, legal representatives, and assigns, any right, title, and interest throughout the world that ASSIGNOR may have in, to, and under the Application and the Work, including all provisional applications relating thereto (including but not limited to U.S. Provisional Application No. 61/102,721, filed October 3, 2008), and all nonprovisional applications claiming priority thereto, including, all divisions, continuations, continuations-in-part, reissues, and reexaminations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all rights of priority under International Conventions and any related Letters Patent which may hereafter be granted or filed in any country or countries foreign to the United States (including but not limited to International Patent Application No. PCT/US2009/059291, filed October 1, 2009 and any national or regional stage applications thereof or relating thereto, including but not limited to European Application No. 09818536.6, which entered the regional stage on April 28, 2011), all extensions, renewals and reissues thereof; and ASSIGNOR hereby authorizes and requests the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all related Letters Patent to the ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

ASSIGNOR does hereby quitclaim, sell, assign, transfer, and convey to ASSIGNEE, its successors, legal representatives, and assigns all claims for damages and all remedies that ASSIGNOR may have arising out of any violation of the rights assigned hereby that may have accrued prior to the date of assignment to ASSIGNEE, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of the said Letters Patent, before or after issuance;

ASSIGNOR hereby covenants and agrees that it will communicate to ASSIGNEE, its successors, legal representatives, and assigns any facts known to ASSIGNOR respecting said


