The Assignor agrees that it will, without further consideration, do all such lawful acts and execute all such documents as may be necessary or desirable to maintain any application claiming the benefit thereof, and any related division, continuation, reissue and extensions of such applications, and to vest title thereto in the Assignee, its successors, assigns and legal representatives or nominees.

The Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America whose duty it is to assign the Letters Patent to the Assignee of the entire right, title and interest in and to the same, for its sole use and benefit, and for the use and benefit of its successors and assigns, to the full end of the term for which the Letters Patent may be granted as fully and entirely as the same would have been held by the Assignor had this Assignment not been made.

This Assignment may be signed in as many counterparts as may be necessary, and may be signed by facsimile or other means of electronic communication producing a printed copy, each of which so signed shall be deemed to be an original, and such counterparts together shall constitute one and the same instrument and notwithstanding the date of execution shall be deemed to bear the date set forth above.


