## ASSIGNMENT OF INVENTION RIGHTS

Each of ASSIGNORS also hereby sells and assigns to ASSIGNEE, its successors, and assigns, the ASSIGNOR'S foreign rights to the Invention disclosed in said application, in all countries of the world, including the right to file applications and obtain patents under the terms of the appropriate laws and or conventions abroad and/or internationally, and further agree to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such patent rights.

Each of ASSIGNORS hereby further agrees that the ASSIGNOR will communicate to ASSIGNEE, or to its successors, assigns, and legal representatives, any facts known to the ASSIGNOR respecting said Invention, and at the expense of ASSIGNEE, testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue and substitute applications, make all lawful oaths, and generally do everything possible to aid said ASSIGNEE, its successors, assigns and nominees to obtain and enforce proper patent protection for said Invention in all countries.

This Assignment may be executed in a number of identical separate counterparts, each of which for all purposes is to be deemed an original, but all of which shall constitute, collectively, one assignment.
