We also agree that, in regard to the Invention, we will communicate to the Foundation or its representatives any facts known to us; testify in any legal proceedings; sign all lawful papers; execute all divisional, continuing, substitute, renewal, reissue, and other applications for letters patent; execute all necessary papers; make all rightful oaths; and generally do everything possible to aid the Foundation, its successors and assigns, to obtain and enforce proper protection for the Invention in the United States, its territorial possessions, and all foreign countries.



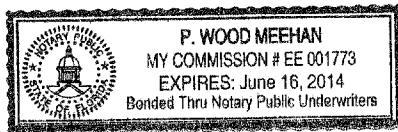

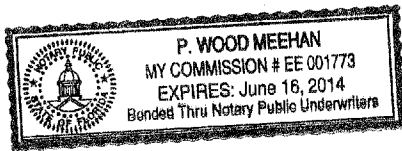
