Assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth.


**AND** for the same consideration, Assignor hereby agrees to now and in the future sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of the Patents, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns, shall advise: that any proceeding in connection with said Patents in any country, including but not limited to interference proceedings, is lawful and desirable; or, that any division, continuation or continuation-in-part of any of said Patents or any reissue, reexamination or extension of any of said Patents, to be obtained thereon, is lawful and desirable. For this limited purpose, Assignor hereby appoints Assignee as its attorney in fact to execute and deliver to Assignee, on behalf of Assignor, any and all such documents or instruments. This appointment shall be deemed to be a power coupled with an interest and shall be irrevocable.

**AND** Assignor hereby grants the following individuals the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document:
